In the month of August 2013 the Washington Township Fire Department held one business meeting, conducted three drills and responded to fourteen emergency calls for a total of 190.19 hours.

The fire department received applications for membership from Dominic Felici. Zachary Kappus, and Robert Falzarano. The applications appear in order; however, I request that the Fire District conduct criminal background checks as well as a driver history check on the applicants prior to approval.

The fire department will be on automatic dispatch with the Washington Boro (83 Fire) and Franklin Twp (57 Fire) Fire Departments for all calls starting at 0600hrs on 9/12/13 and lasting until 1800 hrs on 9/15/13 to combat low staffing due to the Firemen's Convention in Wildwood. The OIC has been designated as F/F Bill Crampton since all line officers will be attending the convention. I am requesting use of Incident Command Unit 76-85 as transportation to the Wildwood Convention. Thank you in advance for your consideration.
