#### **Old Business**

M. Tobin reported that the pensions for the Bureau of Fire Prevention are currently up to date and paid in full with a payment of \$7,775.15 to the New Jersey Division of Pensions and Benefits. M. Tobin also reported that the Annual Employer Appropriation was also paid in the amount of \$1,911.00. Copies of receipts were provided for both payments.

#### **New Business**

- R. Dorio reported that the Workmen's Compensation audit has not yet been completed. R. Dorio will make arrangements with Liberty Mutual to have it completed.
- R. Dorio reported that the fire department wants to purchase tires from Jack Williams Tires and has received a credit application. The necessary changes will be made to the application per Jack Williams Tires customer service and it will be returned to them.
- R. Dorio met with VFIS regarding a claim with 76-74. VFIS will be covering costs of the necessary repairs minus the Board's deductible. VFIS will work with Fire and Safety regarding the amount of the repairs.

#### Resolution #14-011 - Bureau of Fire Prevention Salary Increase

R. Dorio made a motion to increase the salaries of the Bureau of Fire Prevention by 2.4 percent, equal to Washington Township increases. The Fire Official's salary will increase from \$25.82 to \$26.44 per hour, and the Fire Inspector's salary will increase from \$19.66 to \$20.13 per hour. Second was made by C. Shotwell. All were in favor.

Fire Official W. Heerwagen, Jr., requested that the Board turn the Bureau of Fire Prevention back to Washington Township. R. Dorio made a motion to not turn the Bureau of Fire Prevention back to Washington Township. Second was made by C. Shotwell. All were in favor. The Board will continue to maintain the Bureau of Fire Prevention.
