WHEREAS, Subchapter 4, Section 5:31-4.2 further provides that the Commissioners, at their reorganizational meeting, designate, by resolution, the individuals whose signatures shall appear on checks drawn upon the treasury of the Commissioners; and

WHEREAS, Subchapter 4, Section 5:31-4.1(f) provides that the Commissioners shall, by resolution passed by not less than the majority of the full membership, further designate the manner in which the time in which salaries, wages or other compensation for services shall be paid.

NOW THEREFORE, be it RESOLVED by the Commissioners of Fire District No. 1, in the Township of Washington, County of Warren, as follows:

(1) The checks as issued by the Commissioners for payment of claims shall be signed by the Chairman, Treasurer, and countersigned by one other Commissioner in order that the Commissioners comply with the rules and regulations as promulgated by the Local Finance Board and as set forth herein.

(2) No more than one stamp facsimile shall be used on any particular check in place of a handwritten signature.

(3) The manner in which and the time in which compensation for services rendered by employees of the Commissioners shall be paid shall be in accordance with individual employment contracts. The Commissioners' salaries shall be paid as determined by the Commissioners.

During the month of February 2015 the Washington Township Fire Department held one (1) business meeting, conducted three (3) drills and responded to twenty four (24) emergency calls for a total of 259.26 man-hours.

The Fire Department attended a Fire Behavior Course on Sunday, March 8th 2015 at the Califon Firehouse. The training was invaluable and the fire department is planning to host the training for departments in Warren County. The tentative date for this class is May 17th.

A forcible entry class has been scheduled for Sunday March 22nd, 2015 at the Brass Castle Firehouse. Firehouse Innovations, the maker of our newly delivered forcible entry prop, will conduct this training.

The Fire Department's Box Alarms are currently under review and will be posted at both firehouses and placed in all of the apparatus once the review is complete. This added resource will allow members and officers to view the box alarms so they can choose the best option when requiring additional resources

The department had modified its training calendar to include one Tuesday night drill a month instead of all Mondays. This change will allow members to attend drill that typically work Monday Nights.

The Fire Department voted at the March business meeting to sell 76-82 instead of making the repairs that were in excess of 15,000.00.
