During the month of June 2015 the Washington Township Fire Department held one (1) business meeting, conducted four (4) drills, and responded to thirty (18) emergency calls for a total of 295.67 man hours.

The annual service of the Holmatro hydraulic tools was conducted on July 2nd. The tools were reported to be in good serviceable condition.

The accountability tag system that Fire Department is currently using is in the process of being overhauled. The flimsy plastic id cards will be replaced with more rugged anodized aluminum tags. The apparatus tags will have slots designating your riding position and the portable radios will each be assigned a tag with a number that corresponds to the radio id. The new accountability process will involve securing a portable, remove its numbered tag and hook it on to your tag and then hook those tags to the apparatus tag in the appropriate position (Driver, Officer, Seat 1, 2, 3, 4 ETC). The second tag will be retained until entering a IDLH or other work zone. This new process will enhance firefighter safety. In the event a that a may day is transmitted or the man down button is depressed the IC can reference the accountability board to see which member is in distress.

The Fire Department's Box Alarms have been recently revised. The current version involves dividing the township into 4 sectors. North of 57 has been designated zones 1 and 3 and south of 57 has been designated zones 2 and 4. Zone 1 and 3 are divided by Mine Hill Road and Zone 2 and 4 are divided by Route 31. The alarms have been assigned by street so there should not be a need to request the box alarm by number.

I have attached two directives that are effective immediately. The directives are related to the dual response with Washington Borough and the Fire Departments Response to motor vehicle accidents.

The Washington Township Summer Recreation Program has again requested our assistance with the water play days scheduled this summer at Port Colden School. Tender 76-72 will be utilized to provide a water curtain for the children to play in . The three Fridays requested are, 7/17, 7/24, and 7/31.

National Night Out is scheduled for Wednesday August 5th at the Meadow Breeze Park. The Fire Department will display its apparatus and distribute fire prevention materials.

Washington Township and Washington Borough Joint Response Protocol

During the hours of 6 AM to 6 PM Monday to Friday the Washington Township Fire Department and the Washington Borough Fire Department will respond to all calls together in both the Township and Borough. Line Officers/Members will follow the below listed directives during the joint response time period.

Home Agency - Jurisdiction where the call is located.

Assisting Agency - Jurisdiction where the call is not located.

- 1.)The home agency shall not be canceled by the assisting agency when the call is in the home agency's jurisdiction, unless the Home Agency is unable to staff a response in a reasonable time period.
- 2.)The home agency should not immediately cancel the assisting agency during the 0600 to 1800 response time without just cause. The assisting agency should be advised to standby at station or to proceed in with caution. This practice takes into consideration that members during this time period are leaving work or responding during a time of inconvenience.
- 2.)Command will be established by whatever agency's line officer first arrives on scene and conducts a size up. If a home agency line officer is present they will be offered command of the incident, however, if the scope or duration of the incident prevents the transfer of command the assisting agency may keep command. Common sense should prevail in these situations.
- 4.) During the 0600 to 1800 joint response time if a home agency does not have a line officer present the assisting agency line officer shall be in charge. In the event that neither agency has a line officer present, the home agency senior man shall be in charge as long as he/she meets the State of NJ minimum standards.

Motor Vehicle Accident Protocol

Accident With No Injury Or Fire (76 Patrol in Command)- The Washington Township Police Department is responsible for investigating all motor vehicle accidents in the Township. When the Fire Department is alerted for a motor vehicle accident and it is determined that there is no fire or injury the Washington Township Police Department has the authority to cancel or modify (proceed with caution or non-emergency) the Fire Department's Response.

Accident With Injury No Fire (83 Rescue in Command) - The Washington Borough Emergency Squad has been contracted by the Township to provide EMS and Rescue services to the Township. When the Fire Department is alerted for a motor vehicle accident and it is determined that there is injury but no fire the Washington Borough Emergency Squad has the authority to cancel or modify (proceed with caution or non-emergency) the Fire Department's Response.

Accident with Fire (76 Fire in Command) - The Fire Department will respond to all motor vehicle accidents when fire is reported. The Fire Department will not take cancellations from the Police Department or Emergency Squad when there is or was active fire, however, the Fire Department may modify its response based on current conditions, such as no fire or fire out updates.
