Fire Houses:

We would like to clean out our shed and there was some question on how to get rid of stuff, like fire hose, fire equipment, fire turnout gear and so on. If It is broken or damaged are we allowed to throw it away? If it is in working condition but not in use.

We have a vacant spot for are Assistant Chief position. The trustees and body have decided to move everyone up a spot and the appoint a Lieutenant. This will take effect come May. The officers are out looking for good prospect. We have finally signed a lease to house the fire district office and trucks. When The term of the lease is over the fire department officers would like to sit with a district rep and review and change some stuff on the lease for instance we would like to have a one year term lease.

Strategic Planning:

Our department needs a master plan. I am working with the leadership of the department and district to help put this together. It's not going to happen overnight so we are taking our time to come up with a well thought out future plan. So far, we are looking to purchase a new Tanker because the current tanker 76-72 is 3 to 4 years past our standard replacement time of 20 years. There is a lot of rust spots in the tank along with a leak that may not be able to be fixed. The pump on the truck is failing, and it need all 6 new tires as that are out of DOT compliant. we just seem to be dumping a lot of money to keep it in service. Also, we are considering expanding the Washburn fire house bays. This is needed so that we can fit todays standard size fire apparatus. This will help save money for any truck purchases down the road. Plus, if we need to rotate the apparatus around from one fire house to the other we will be able to. There is also a need to buy all new air pack for the fire department as our pack are out of date and unserviceable.

Junior Program / Cadet Program:

This program is taking off we now have about 15 members that are involved they have their own drills, their own leaders. We have 2 firemen supervising their activities and they are teaching and leading them toward being future firemen.

Good of the Order:

The Harrisburg fire convention will be held towed the end of May some were near the 19th. I feel we should have some guys go to check out what is new to our field.
